LICENSING CONDITIONS FOR OPERATING CRANE / GAME MACHINES AT PREMISES

Note: For the avoidance of doubt, all references to the "licensee" in the following licensing conditions include a **co-licensee**, i.e. an individual/business entity who jointly holds a PE licence with another individual/business entity.

Note: All examples in this License are not meant to be exhaustive definitions of the terms "reasonable measures", "reasonable steps" or "reasonable control", as the case may be.

1 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that no students wearing his or her school uniform or any part of a school uniform, or a school T-shirt, is permitted to play at any of the machines in the licensed premises.

2 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that the machine(s) is/are placed within the licensed premises. The licensee must obtain the approval of the Town Council if the machine(s) is/are to be placed at the common area of HDB premises.

3 Except for the items listed below, the licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must obtain the approval of the Licensing Officer for any other items to be offered as prizes:

- (a) Toys
- (b) Key chains
- (c) T-shirts
- (d) Note books
- (e) Jigsaw puzzles
- (f) Waist pouches
- (g) Watches

4 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that the pin-tables deployed in the licensed premises are of a type approved by the Licensing Officer.

5 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that no gambling or betting takes place in the licensed premises.

6 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that a sign prohibiting gambling and betting in the licensed premises is displayed at a conspicuous place within the premises.

7 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must not permit any person below 16 years of age to use any of the pintables in the licensed premises on any school day except between 6.30p.m. and 11.59p.m.

8 The licensee whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must not provide, or cause or permit to be provided, to change of clothes to any student.

9 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must take all reasonable steps necessary to ensure that the public entertainment is not likely to be offensive to any race, religion, ethnicity or nationality or potentially cause disharmony amongst different groups.

An example of what could be a "reasonable measure" is set out below:

 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, conducts regular inspections of the licensed premises to identify and cease any activity that may be offensive to any race, religion, ethnicity or nationality, or potentially cause disharmony amongst different groups.

10 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure compliance with all prevailing laws, rules, regulations and regulatory conditions/requirements/guidelines that are applicable to the licensed premises and/or the public entertainment provided, including but not limited to those pertaining to fire safety. 11 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that the value of any prize offered in the licensed premises does not exceed S\$100 (one hundred Singapore dollars).

12 The licensee, whether personally or through any officer, employee, agent and/or contractor employed for this purpose, must ensure that:

- cash, cash equivalents, credit, merchant vouchers or coupons are not allowed as prizes; and
- any sell-back of prizes to any operator is prohibited.
