

PREAMBLE

1. Under the Infrastructure Protection Act, security plans for Special Developments/Special Infrastructure must be prepared by a Competent Person(s).
2. Security consultants who pass security screening (project-specific) and meet the general competence requirement will be approved as Competent Person (Security) by the Commissioner of Infrastructure Protection. To meet the general competence requirement, individuals must have either:
 - a. Relevant experiences (in recent 3 years) in the preparation of Security Plans (Threat, Vulnerability and Risk Assessment (TVRA) and Security Protection Plan (SPP) deliverables) under the MHA Security-By-Design (SBD) Review Process; or
 - b. *[Depending on the nature of Project]* Relevant subject matter expertise and knowledge, with accredited referee reports or internationally published professional work.

In the future, individuals with specified professional accreditations will also be deemed to have met the general competence requirements.

3. Blast consultants who pass security screening (project-specific) and meet the general competence requirement will be approved as Competent Person (Blast) by the Commissioner of Infrastructure Protection. To meet the general competence requirement, individuals must have either:
 - a. Relevant experiences (in recent 3 years) in the preparation of Security Plans (Blast Effect Analysis (BEA) and Structural Resiliency Study (SRS) deliverables) under the MHA Security-By-Design (SBD) Review Process; or
 - b. Registered as a Specialist Professional Engineer (Protective Security); or
 - c. *[Depending on the nature of Project]* Relevant subject matter expertise and knowledge, with accredited referee reports or internationally published professional work.
4. **We strongly encourage Responsible Persons to review the suitability of the security/blast consultants based on the nature of works for your Special Development/Special Infrastructure.** This information is intended for uses related to the Infrastructure Protection Act, and does not constitute legal, professional or commercial advice.
