

Guideline on Prohibited, Controlled and Non-Regulated Items

This guideline is for:

- **Travellers** bringing items into Singapore
- **Online shoppers** purchasing items from overseas or local websites
- **Members of the public** who own or are considering acquiring certain items

Read this **before** you travel to Singapore, make online purchases, or acquire items that may be regulated.

Why These Controls Exist

Singapore maintains strict controls on certain items to ensure public safety and security. These items include guns, firearms, weapons, explosives, explosive precursors, noxious substances etc. The Police Regulatory Department (PRD) is the authority responsible for regulating such controlled items.

These regulations help prevent misuse of dangerous items, ensure responsible and legitimate use, and maintain a safe and secure environment for the community. Any import, possession or handling of such items without necessarily approval may constitute an offence.

Important: Online Availability Does Not Mean Legal to Import or Possess

Just because an item is available for purchase online does not mean it is legal to import into or possess in Singapore.

Many overseas and local websites sell items that are prohibited or controlled under Singapore law.

Before purchasing any item that may be regulated:

1. Check this guideline and the attached annexes
2. Visit PRD's website for more information and FAQ
3. Verify requirements with the PRD if unsure
4. Obtain necessary approvals before importing

You are responsible for ensuring compliance with Singapore's regulations.

Quick Reference: Is My Item Regulated?

Step 1: Check the attached annexes

- Found in **Annex A**? → **PROHIBITED** - Cannot import or possess
- Found in **Annex B**? → **CONTROLLED** - Need PRD approval before import
- Not listed? → Proceed to Step 2

Step 2: Even if not listed, consider:

- Could this item be used as a weapon?
- Do I have a legitimate reason to possess the item?
- Could the item cause public alarm?

Category 1: Prohibited Items - See *Annex A* for the complete list.

What Are They?

Items that **cannot be imported into or possessed in Singapore under any circumstances**. They are considered prohibited weapons or are otherwise banned under Singapore law.

Legal Consequences

Possession without lawful authority is a criminal offence punishable by imprisonment, fines, or both.

What to Do

- **If you already own one:** Surrender to the Police immediately
- **If travelling with one:** Declare it immediately to Customs/ICA officers upon arrival

Category 2: Controlled Items - See *Annex B* for the complete list.

What Are They?

Items that **require prior approval from PRD before import** into Singapore.

Legal Requirement

You must obtain approval (import licence, permit, authorisation or approval letter) from PRD **before importing**.

Importing without approval is an offence and may result in seizure, prosecution, fines and/or imprisonment.

How to Apply

Submit application to PRD before purchasing or importing:

- Visit PRD's website for application procedures: <https://www.police.gov.sg/Business-E-Services/Apply-for-Gun-Licence/Overview-of-Gun-Explosive-Weapon-Licences>
- Processing time: Typically 2- 3 weeks
- Only proceed with purchase/import after receiving written approval

Licensing Requirements

PRD evaluates applications based on:

- Legitimate need for the item
- Proposed security measures
- Intended use
- Applicant's background and suitability

Different requirements apply:

For Businesses/Entities:

- Licences issued for business operations involving controlled items
- Restricted to scope of approved business activities

For Individuals:

- Approvals granted on a case-by-case basis for specific approved activities only
- Must demonstrate clear legitimate need

Key Points for Online Shoppers

- Check ***Annex B*** before purchasing
- Apply for PRD approval first
- Only complete purchase after receiving approval from PRD
- Provide approval document to shipping company/courier
- Present approval to Singapore Customs / Immigration and Checkpoint Authority (ICA) upon arrival

Key Points for Travellers

- Apply for approval at least 2 weeks before travel
- Declare items to Customs/ICA upon arrival
- Present approval document when requested
- Items without approval will be seized

Category 3: Class Licensing under GEWCA

What Is It?

A simplified regulatory approach for certain controlled items used for specific approved purposes. It reduces administrative burden by allowing automatic licensing when you comply with all requirements. There is no need to apply licence or inform PRD.

How It Works

You are automatically considered licensed when you:

1. Import, Export or Use controlled items only for authorised purposes specified in the Class Licence Orders
2. Comply with all conditions in the relevant Class Licence Order
3. Meet all security and safety requirements

You can begin activities immediately without submitting applications, paying fees, or waiting for a licence.

When You Need a Regular Licence

If your use does not fall within Class Licence conditions, you must apply for a regular licence from PRD.

Consequences of Non-Compliance

Breaching Class Licence conditions may result in:

- Revocation of Class Licence privileges
- Requirement to obtain regular licence
- Seizure of items
- Prosecution

When in doubt, apply for a regular licence.

Category 4: Non-Controlled Items - See Annex C for the examples

What Are They?

Items that are not regulated and do not require PRD approval for import. However, possession is not unrestricted.

Requirements

You must:

1. **Have a legitimate reason** for possessing them
 - Examples: Professional use, sporting activities, household use, recreational activities
2. **Not use or intend to use them to cause harm or public alarm**

Police May Investigate If:

- You cannot explain why you possess the item
- Circumstances suggest potential misuse
- Item is carried in public without legitimate purpose or cause public alarm
- There are concerns about your intent

Best Practices:

- Keep items secured when not in use
- Transport items securely and discreetly
- Be prepared to explain legitimate purpose if questioned
- Don't carry items in public unnecessarily

Summary Checklist**Before You Buy an Item or Travel:**

- ✓ Check this guideline and the attached Annexes
- ✓ Check PRD's website on GEWCA and its FAQ
- ✓ Verify regulatory requirements with PRD if unsure
- ✓ Apply for necessary approvals before purchasing or travelling
- ✓ Declare items to Customs/ICA when entering Singapore
- ✓ Keep approval documents accessible during import

Don't:

- ✗ Assume online availability means legal to import
- ✗ Rely on sellers to handle compliance
- ✗ Import without proper approval for controlled items
- ✗ Attempt to bring in prohibited items under any circumstances

Annex C - List of Non-Regulated Items (This is not an exhaustive list)

The items listed below are not meant to be exhaustive. Some of these items may also be deemed as offensive weapons depending on the circumstances they are found. For example, if a traveller is found to have a knife hidden around his ankle and is unable to provide a reasonable explanation, then he may have committed an offence under the CESOW or the MOA.

2.	Bomb Bags/ Magic Popping Bomb Bags ¹³
3.	Manual Foldable Knife / Swiss Army Knife

7.	Ornamental Model ¹⁵ made from empty bullet cartridges ¹⁶ which is permanently assembled and do not cause public alarm. The model is non-functional, and its individual components cannot be removed or dismantled.
8.	Magician Handcuffs (with release lever)
9.	Gun Tripods / Gun Slings
10.	Gun Sights / Scopes

¹³ Bomb bag does not contain explosives composition and works by a harmless acid-base reaction (usually using baking soda with citric acid / vinegar) that creates gas to expand and burst the outer sachet. When the inner bag is squeezed, the sachet is expanded till the sachet pops.

¹⁶ It is traveller's onus of responsibility to show proof that the models are made of empty or inert cartridges. Simply claiming that the cartridges are empty or inert is not enough. If authorities cannot be convinced that the items are safe, importation will be treated as controlled item under Explosives which will result in seizure and investigation. If in doubt, travellers should refrain from importing the item.

Annex D - Frequently Asked Questions (FAQ)¹⁷

General Questions

Q1: I bought a foldable knife online. What should I do?

Manual foldable knives are not regulated. There is no requirement to seek approval for the import or possession.

Q2: An item is legal in other countries. Can I bring it to Singapore?

No. Each country has its own laws. Items legal elsewhere may be prohibited or controlled in Singapore. Always check Singapore's regulations first.

Q3: I'm transiting through Singapore with Firearms and Ammunitions. Do these rules apply?

Yes, the exemption criteria for transiting with firearms and ammunitions are covered under the Guns, Explosives and Weapons Control (Aviation Industry — Exemption) Order 2025. You must declare to the airline that you are travelling with firearms (and/or ammunition) in advance. If the airline permits the traveller to travel with firearms, the airline will engage the ground handling services in Changi Airport to deploy armed Auxiliary Police Officers (fees applies) to carry out the transit of the firearms in Singapore.

You must not carry in person or place the firearms into the check-in and carry-on board baggage. The firearms and ammunition must be tagged as security items and handled separately by the airline.

Q4: Can I ship items to Singapore as gifts?

Yes, but the recipient is responsible for compliance. Prohibited items will be seized. Controlled items require the recipient to have prior PRD's approval.

Q5: What happens if Customs seizes my item?

Prohibited items are permanently seized and you may face prosecution.

Controlled items without approval are seized and you may face prosecution. Re-export may be possible in some cases, subject to approval.

For Online Shoppers

Q6: I already ordered a controlled item without approval. What should I do now?

Contact PRD immediately to explain and apply for approval. Provide order and tracking details. Don't accept delivery until you receive PRD guidance.

Q7: The seller says they'll handle import requirements. Can I rely on this?

No. You as the importer are responsible for compliance. Many overseas sellers don't know Singapore's regulations. Always verify with the requirements yourself.

Q8: I bought from a local Singapore website or online platforms/app. Is it legal?

Not necessarily. Some local sellers may operate illegally or have business licences but cannot transfer items to unlicensed individuals. Verify before purchasing.

Q9: Can I buy controlled items if I have a valid reason?

Possibly. Apply to PRD and demonstrate legitimate need. Approval is case-by-case. Reasons like "self-defence" or "personal collection" or "historical or cultural preservation" are generally insufficient for individuals.

Q10: How can I determine the chemical composition of a substance or an item?

The chemical composition can be determined by referring to the Safety Data Sheet (SDS) provided for the substance or item. The SDS contained verified information about the chemical ingredients and their properties. You should obtain from the seller or manufacturer.

For Travellers**Q11: I'm bringing sports equipment for a competition. Do I need approval?**

Check **Annex B**. Some sports equipment may be controlled. If controlled, apply before travelling and bring supporting documents (competition invitation, club membership).

Q12: I forgot I had a controlled item in my luggage. What should I do?

Declare it immediately to Customs/ICA upon arrival. Voluntary declaration may be viewed favourably. Attempting to bring it through without declaration results in more serious consequences.

Q13: Can I bring replica/toy guns for my children?

Replica firearms are controlled and require PRD's approval. Replica or Toy guns resembling real firearms will not be approved for import and may be seized. Check the sample list of approved and disallowed toy gun models at <https://www.police.gov.sg/Business-E-Services/Apply-for-Gun-Licence/Guide-for-Import-Toy-and-Replica-Gun>. If in doubt, it is safest to refrain from importing the item.

Q14: I'm moving to Singapore permanently. How do I bring controlled personal items?

Apply for PRD's approval well in advance (at least 3 weeks). Provide relocation documentation and explain legitimate purpose for each item. Some items may not be approved even for personal use.

Q15: Does it mean that I can bring non-regulated items on a flight/vessel/vehicle?

No. An item not regulated by PRD does not automatically mean it is allowed. Operator of an aircraft/vessel/vehicle may not allow passengers to take certain items (e.g. knife, scissors) onboard. The operator reserves the right to bar the passenger from boarding if he does not comply with the instructions (e.g. dispose or surrender the items). In this situation, whether the item is class licensed, exempted or unregulated under existing law is immaterial.

About Licensing and Applications**Q16: How long does approval take?**

Generally 2 – 3 weeks from application and submission of **all necessary and completed set of supporting documents**. Complex cases and incomplete submissions take longer. Apply early and don't make purchases or travel arrangements until approved.

Q17: Where can I find application procedures?

Q18: I was approved for a specific purpose. Can I use the item for other purposes?

No. Approvals are granted for specific purposes only. Using items outside approved scope breaches licence conditions and may result in revocation and prosecution.

Q19: My business has a licence. Can employees take items home?

Generally no, unless specifically approved by Licensing Officer. Business licences typically restrict items to business premises and authorised personnel. Check your licence conditions or contact PRD.

Q20: How do I know if I qualify for Class Licensing?

Review the relevant Class Licence Order at <https://sso.agc.gov.sg/Act/GEWCA2021?ViewType=SI>. If your situation matches all conditions precisely, you qualify. Any deviation requires a licence.

Q21: I operate under Class Licensing. Do I need to notify PRD?

You don't need to apply for a licence but must comply with all Class Licence Order conditions. Some Orders may require record-keeping or activity notifications. Check your specific Order.

About Enforcement**Q22: What are the penalties for importing prohibited items?**

Penalties vary but may include imprisonment, fines, or both. Refer to relevant legislation under the Guns, Explosives and Weapons Control Act 2021.

Q23: I saw someone selling controlled items online without mentioning licensing. Should I report this?

Yes. Provide as many details as possible (what, where, when, who) to aid investigations when report the illegal activity in Singapore.

Q24: Can I surrender an item I no longer want?

Owners are responsible for the disposal of licensed or non-regulated items in their possession.

For non-regulated items:

There is no need to surrender non-regulated items to the Police for disposal. Owners may dispose of these items themselves, but must ensure safe disposal practices:

- Wrap sharp objects securely to prevent injury to waste handlers
- Package items to avoid causing public alarm (e.g. conceal weapon-like shapes)
- Dispose at designated rubbish collection centres or through licensed disposal companies
- For large or hazardous items (e.g. metal weapons), consider engaging metal recycling companies
- Ensure disposal methods comply with NEA guidelines

For controlled items (items for which licences have been issued):

Approval from PRD is required before disposal. Licensees must:

1. Notify PRD on the intent to dispose
2. Obtain approval and disposal instructions from the licensing officer
3. Dispose of the item according to the requirements and conditions specified by PRD
4. Provide proof of disposal if required

Do not dispose of licensed items without prior PRD's approval, as this may breach licence conditions.

Getting Help**Q25: I am still unsure if my item is regulated. Who can I ask?**

If you are unsure about the permissibility of an item, it is safest to refrain from importing the item.







