GUIDELINES FOR EXPLOSIVE PRECURSORS TRANSPORT LICENCE APPLICATION

The transportation of Explosive Precursor is class licensed under Guns, Explosives and Weapons Control (Transporting Explosive Precursors - Class Licence) Order 2025. However, if the Class Licence order is disapplied or if the transportation activities fall outside the scope of the Class Licence Order, a Licence to Transport Explosive Precursor would be required.

A. General Requirements

- 1. Application Fee (as specified in Third Schedule)
- 2. Basic Information Required:
 - Applicant's identity particulars, telephone number, email address and contact address
 - o Address of all premises used for transport activities
 - At least one Singapore-based authorised representative's full name and contact address

B. Personnel Information Required – To Provide list of Personnel during Application

- 1. For Each Supervisor of Transport Activities:
 - o Identity particulars and contact address
 - Position in operations
 - Security clearance (if special worker or responsible executive)
- 2. For Vehicle Drivers:
 - HAZMAT driving licence (required only if Explosive precursor mass exceeds 3 tonnes)
 - Knowledge and training certification regarding:
 - Nature and hazardous properties of explosive precursors
 - Accident prevention precautions
 - Emergency response procedures

C. Required Plans and Documentation

- 1. Safety Management Plan containing:
 - Risk management procedures
 - Safety policies and procedures
 - o Emergency response plan including:
 - Spillage control procedures
 - Firefighting equipment provisions
 - First aid availability
 - Evacuation plan
 - Compliance monitoring procedures
- 2. Security Plan containing:
 - Security risk identification
 - Security facilities and systems details
 - List of individuals with unsupervised access
 - Record-keeping procedures
- 3. Transport Security Plan including:
 - Detailed route description
 - Start/end locations and stops (list all known locations)
 - Vehicle specifications

D. Technical Information Required

- 1. Precursor Details:
 - o UN Number and classification code
 - o Commercial name (if applicable)
 - Safety data sheets

- Quantity to be transported
- 2. Vehicle Information:
 - Vehicle number
 - o Vehicle specifications (model, width, height, unladen weight)
 - Vehicle suitability certification
 - o Vehicle marking compliance with SS586 or ADR

E. Operational Requirements

- 1. Route Restrictions:
 - Must avoid densely populated areas
 - Must avoid road tunnels
 - Must avoid peak traffic periods
 - Must avoid Central Business District
- 2. Safety Requirements:
 - o No individuals under 18 years allowed
 - No public passenger transport vehicles
 - o Vehicle must not be left unattended in public places
 - o Only authorised crew members allowed in vehicle
 - Precursors must be packed according to ADR requirements
 - Precursors must be stored in secure, locked depositaries
 - Precursors must remain covered during transport
 - No unpacking or opening during transport
 - o Transfer only to authorised persons with proper documentation
