Unless exempted by the Licensing Officer, all applicants for a security agency (SA) licence (whether new licences or licence renewals) taking effect from 1 Jan 2022 are required to pass the Security Agencies Competency Evaluation ("SACE") conducted by Police Regulatory Department (PRD) and Ministry of Manpower (MOM)
 - a) Applicants who have obtained a 'Pass' in all SACE core competencies are eligible for a 1-year licence;
 - b) Applicants who have obtained a 'Pass' in all SACE core competencies and are 'Competent' in at least 5 elective competencies from the 4 prescribed categories are eligible for a 2-year licence.
- 2. Besides SACE, applicants must also fulfil other relevant licensing criteria which can be found on SPF's E-Services website at https://www.police.gov.sg/Business-E-Services/Apply-for-Security-Agency-Licence
- 3. Service buyers may request for the security agency to produce a copy of its valid licence
