

## **Frequently Asked Questions (FAQ)**

**Q1: My birthday is on 6 August 2020. Am I eligible for the six-month extension?**

**A1:** Yes. Motorists whose birthdays fall between 7 April and 6 August (both dates inclusive) and meet all conditions below, are eligible:

- a. Aged 65 years or above;
- b. Driving licence is in force; and
- c. Driving licence is due for revalidation in 2020.

**Q2: I qualify for the six-month extension. By when must I submit my medical examination report and proficiency driving test results (applicable only for Class 4, 4A and 5 driving licences)?**

**A2:** You are required to submit the relevant documents within six months from the date of your birthday. So if your birthday falls on 10 April, you must submit the documents by 10 October 2020.

**Q3: I qualify for the six-month extension. When should I undergo the medical examination and the proficiency driving test (applicable only for Class 4, 4A and 5 driving licences)?**

**A3:** You are required to submit a medical examination report that is dated no more than two months before the extended deadline for submission of documents for revalidation. For example, if your licence is due for revalidation on 10 October 2020, your medical examination report should not be dated earlier than 10 August 2020.

For motorists who have a Class 4, 4A or 5 driving licence, you are likewise required to pass the proficiency driving test no more than two months before the extended deadline. For example, if your licence is due for revalidation on 10 October 2020, you should not attempt the proficiency driving test earlier than 10 August 2020.

**Q4: I have a Class 1, 2, 2A, 2B, 3 or 3A driving licence. My deadline to submit the medical examination report has been extended from 10 April 2020 to 10 October 2020. If I revalidate my licence by 10 October 2020, when is the next time I have to revalidate my licence?**

**A4:** If you have a **Class 1, 2, 2A, 2B, 3 or 3A driving licence**, you are required to submit your next medical examination report before you reach the next prescribed age\* on your birthday, in order to revalidate your licence. For example, if you reach 65 years of age on 10 April 2020 and revalidate your licence by 10 October 2020 with the extended deadline, you must revalidate your licence again by 10 April 2023 when you reach 68 years of age.

*\*Holders of a Class 1, 2, 2A, 2B, 3 or 3A driving licence must undergo a medical examination and submit the report to revalidate their licence every three years once they reach 65 years of age. Hence, they must revalidate their licence when they are 65, 68, 71, 74 ... years of age.*

**Q5: I have a Class 4, 4A or 5 driving licence. My deadline to submit the medical examination report and proficiency driving test results has been extended from 10 April 2020 to 10 October 2020. If I revalidate my licence by 10 October 2020, when is the next time I have to revalidate my licence?**

**A5:** If you have a **Class 4, 4A or 5 driving licence**, you are required to submit your next medical examination report before you reach the next prescribed age\* on your birthday, in order to revalidate your licence. For example, if you reach 65 years of age on 10 April 2020 and revalidate your licence by 10 October 2020, you must revalidate your licence again by 10 April 2021 when you reach 66 years of age.

*\*Holders of a Class 4, 4A or 5 driving licence must revalidate their licence every year once they reach 65 years of age. Hence, they must revalidate their licence when they are 65, 66, 67, ..., 74 years of age. Those aged 75 years or above cannot hold a Class 4, 4A or 5 licence.*

**Q6: What happens if the circuit breaker period is extended past 1 June 2020?**

**A6:** Traffic Police will monitor the situation closely and will review the extension period for licence revalidation if necessary.
