** A type A licence allows a licensee to operate the specified establishment up to 1 a.m. every Monday to Saturday and 2 a.m. every Sunday and public holiday, subject to the conditions set out by the Licensing Officer in the licence.*

A type B licence allows a licensee to operate the specified establishment up to 3 a.m. every Monday to Saturday and 4 a.m. every Sunday and public holiday, subject to the conditions set out by the Licensing Officer in the licence.

§ A type C licence allows a licensee to operate the specified establishment up to 6 a.m. daily, subject to the conditions set out by the Licensing Officer in the licence.

† The licence is valid for any 7 days, consecutively or otherwise, within a period of 3 months.
