PROTECTED AREAS (AMENDMENT)
ORDER 2018

In exercise of the powers conferred by section 4(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Protected Areas (Amendment) Order 2018 and shall come into operation on 2018.

Amendment of Schedule

2. Item (9) in the Schedule to the Protected Areas (Consolidation) Order (O 4) is amended by deleting paragraph 3 and the plan thereunder and substituting the following paragraph and plan:
