- Providing funds, or allowing premises to be used for loansharking business
- Providing or selling prepaid SIM cards to loansharks
- Promoting or advertising loansharking activities
- Providing transport for runners
- Acting as lookout or verifying debtor identity on behalf of loansharks

## Help Fight Against Loansharks. Call 999

- Report suspicious persons in the neighbourhood & loansharking activities immediately
- Do not borrow money from loansharks
- Do not lend your IC to anyone
- Never be a guarantor for any illegal loan
- Seek help if you are a compulsive or excessive gambler



Turning to Ah Longs is the surefire way to a living hell. It is a debt that you can never finish paying. You and your family will be harassed, often in vicious, life-threatening ways. You could be forced to become their runner or harasser. The long arm of the law will catch up with you. Don't get involved in illegal moneylending activities. It does not pay.

Ah Longs force me to harass other debtors. Splashing paint, making threatening phone calls... I have done it all. I am jailed for 4 years now. My wife is jobless and my kids are still so young. 9 9


